Section 97 of the Myanmar Companies Law 2017 provides that every company must within 2 months of its incorporation and once at least every year (but month after the anniversary of its incorporation) file a return of its particulars with the Registrar, which is called the Annual Return.

All companies must file an Annual Return with the Registrar. Failure to file an annual return may result in the company's registration being suspended and struck off.

To complete this Annual Return, check and confirm that the company details held by the Registrar as shown on the "Myanmar Companies Online" (MyCO) complete and up to date. If any changes to the company details on the MyCO Registry are required, notify the Registrar of the changes using the applicable form. The Annual Return cannot be filed until all particulars are accurate in the MyCO Registry and each section can be confirmed to be accurate.

Note: Public companies must send their last financial statements to the Registrar at the same time as the annual return under section 266(a) of the Myanmar Companies Law 2017 using Form G-5 | Financial statements of public company.
